

## INTERNATIONAL OPTISPRING REGATTA OPTISPRING CHALLENGE CUP

### NOTICE OF RACE (status: issued, 02/11/2017)

---

**April 07-08, 2018, Port Zélande, The Netherlands**

#### 1. Venue

The International Optispring Regatta will be held on April 07<sup>th</sup> and 08<sup>th</sup>, 2018 and will be sailed on the **Grevelingen Lake** (the Netherlands), outside Marina Port Zélande. See App. A. The event is organized by the Dinghy Optimist Class Belgium vzw (DOCB) in co-operation with the Royal Yacht Club of Belgium vzw (RYCB).

#### 2. General

The Sailing Instructions will be published at the latest one week before the event on the website under [www.optispring.be](http://www.optispring.be) and can be downloaded as PDF document. They will not be handed over at registration. All participants are requested to register online, and shall confirm their participation at the Race Office. The Race Office will be established in the Harbour Office of Marina Port Zélande. Support boats: see § 14.

#### 3. Class

Open to all International Optimist Dinghies (all levels of optimists). The International Optispring Regatta counts as a qualifying regatta for the IODA European and World Championships 2017 for Belgian and Dutch Optimists.

#### 4. Rules

The International Optispring Regatta will be governed by the rules as defined in the World Sailing Racing Rules of Sailing and the IODA class rules.

#### 5. Advertising

Advertising in accordance to World Sailing regulation 20 and IODA Class Rule 2.8. Each boat is required to display on both sides of her hull the stickers of the event-sponsor, if any.

#### 6. Conditions of Entry

Each boat shall be a full member of her national class association. All boats and equipment must have valid measurement certificates. Random checks can be performed by the organizing comity of the (record of) equipment used for this regatta. This record can be downloaded from the website, [www.optimist.be](http://www.optimist.be). Boats shall carry on the sail the letters and numbers issued by the national class association.

#### 7. Disclaimer of Liability

Participants compete entirely at their own risk and responsibility. The DOCB, R.Y.C.B., the race committee or any person directly or indirectly involved in the organization shall not be liable for injury, personal or material damage, loss or claim, ashore or afloat, which might result from participation or intention to participate in this event.

Rule 4 of the Racing Rules of Sailing states: "The responsibility for a boat's decision to participate in a race or to continue racing is hers alone." Sailing is by its nature an unpredictable sport and therefore inherently involves an



element of risk. By taking part in the event, each competitor, each parent present or not, each coach agrees and acknowledges that:

- a) They are aware of the inherent element of risk involved in the sport and accept responsibility for the exposure of themselves, crew and their boat to such inherent risk whilst taking part in the event;
- b) They are responsible for the safety of themselves, crew and their boat and their property whether afloat or ashore;
- c) They accept responsibility for any injury, damage or loss to the extent caused by their own actions or omissions;
- d) Their boat is in good order, equipped to sail in the event and they are fit to participate;
- e) The provision of a race management team, patrol boats and other officials and volunteers by the event organizer does not relieve them of their own responsibilities;
- f) The provision of patrol boat cover is limited to such assistance, particularly in extreme weather conditions, as can be practically provided in the circumstances;
- g) Their boat is adequately insured.

Parents/guardians not personally attending any part of the event must ensure that another adult is authorized and designated to make these decisions for their sailor.

## 8. Insurance

All boats must carry a valid third-party liability insurance with a minimum cover of € 500.000,- per event.

## 9. Pre-registration & Entry Fee

All entries shall be made by on-line registration at [www.optispring.be](http://www.optispring.be) . **By registering, you are on the waiting list. After payment your entry will be final.** The online registration should allow you to perform direct online payment.

If for any reason your pre-registration cannot be confirmed by direct online payment, your entry will be on the waiting list. Please contact DOCB via [regatta@optimist.be](mailto:regatta@optimist.be) in this case.

Entry fee:

- €65 if online entry and payment before 25-03-2018
- €80 from 26-03-2018 onwards

Optimist entries will be limited to **240** boats, pre-registered and payment confirmed.

## 11. Scoring System

The Low Point Scoring System (Appendix A of the RRS) will apply. A minimum of three races have to be completed to constitute a series. The total number of races shall not exceed 7 (seven). In accordance with RRS App A, a boat's series score will be the total of her race scores excluding her worst score, except if less than 4 races have been completed, in which case the series score will be the total of her race scores.

## 12. Prizes

Prizes will be awarded to:

- The first 10 individual competitors
- The 1st, 2nd and 3rd Benjamin (born in 2006 or later)
- The Optispring Challenge Cup: is the challenge trophy that will be awarded to the team of the country with the best total team score, the 1st Country Team. The total team score is calculated from the cumulated end results (points) of the first three individual sailors from each country.

## 13. Results

Results will be available as soon as possible after the event on [www.optispring.be](http://www.optispring.be).

## 14. Support Boats

All support boats are requested to register online before 25-03-2018 on [www.optispring.be](http://www.optispring.be). All support boats shall fly a flag provided at the race office.

- A deposit of 10€ must be paid in cash in the regatta office at registration. This deposit will be restituted after return of the flag.
- There is free use of slipway and free mooring in the Rib Area when registered. See App. B.
- Support boats can be requested to help with towing the sailors to the race area and back to the harbour.
- The speed limit on the Grevelingen Lake is 15 km/h.

## 15. Event Traffic

Local traffic stream for cars with boats and trailers will be indicated on site. General guidelines will be announced on the website. See also App. A.
