### **Notice of Race**

#### **1. RULES**

- 1.1 The regatta will be governed by the Racing Rules of Sailing (RRS), except as any of these are altered by this Notice of Race and/or by the Sailing Instructions.
- 1.2 The Rules of the International Optimist Dinghy Association, the Rules of the International Laser Class Association, the Rules of the International Sunfish Class Association and the Rules of the Snipe Class International Racing Association (SCIRA) will apply, except as any of these are changed by these Notice of Race and/or by the Sailing Instructions.
- 1.3 English shall be the official language for the Race.

#### **2. ELIGIBILITY AND ENTRY**

- 2.1 All registrants must be a current member of the class association (RRS75.2 Competitors shall comply with ISAF Regulation 19, Eligibility Code).
- 2.2 If you are not a current member of the class association, membership to the association will be available for a nominal fee.
- 2.3 Eligible boats may be entered by completing registration with the CNSJ regatta committee.
  - 2.3.1 Optimist (Green)(White)(Blue)(Red)
  - 2.3.2 Laser (4.7)(Radial)(Standard)
  - 2.3.3 Sunfish
  - 2.3.4 Snipe

#### **3. FEES**

- 3.1 Early Registration – for entries on or before December 1<sup>st</sup>, 2009.
  - 3.1.1 Optimist / Laser / Sunfish \$100.00
  - 3.1.2 Snipe \$130.00
- 3.2 Registration – for entries after December 1<sup>st</sup>, 2009 and before January 19<sup>th</sup>, 2010.
  - 3.2.1 Optimist / Laser / Sunfish \$130.00
  - 3.2.2 Snipe \$160.00
- 3.3 Late Registration – for entries after January 19<sup>th</sup>, 2010.
  - 3.3.1 Optimist / Laser / Sunfish \$160.00
  - 3.3.2 Snipe \$190.00

9.1 All visiting boats will be accommodated by the sailing Program Area.

Competitors also agree to take any and all responsibility for damages caused to third persons or their belongings, to themselves or to their belongings, ashore and at sea as a consequence of their participation in the regatta, relieving of any responsibility the Clun Nautico de San Juan and all persons involved in the organization under whatever qualification. Competitors are to be acquainted with ISAF RRS Part 1 Fundamental Rule 4: "The responsibility for a boat's decision to participate in a race or to continue racing is hers alone". In any case, competitors agree that the Club Nautico de San Juan, the sponsors and their agents, have no responsibility for loss of life or injury to members or others or
