



INTERNATIONAL OPTISPRING REGATTA OPTISPRING CHALLENGE CUP

NOTICE OF RACE

(January 13, 2009)

April 17-18, 2010, Port Zélande, The Netherlands

1. Venue :

The International Optispring Regatta will be held on **April 17-18, 2010** and will be sailed on **the Grevelingen Lake** (Netherlands), outside Marina Port Zélande. See App. A. The event is organized by the Dinghy Optimist Class Belgium vzw (DOCB) in co-operation with the Royal Yacht Club of Belgium vzw (RYCB).

2. General :

The sailing instructions will be available at the Race Office at the latest **one week** before the event on the website www.optispring.be and at the race office. All boats are requested to confirm their online pre-registration and payment at the Race Office. The Race Office will be established near the Harbour Office of Marina Port Zélande. Support boats: see § 14.

3. Class :

Open to all International **Optimist** Dinghies (all levels of optimists). The International Optispring Regatta counts as a qualifying regatta for the IODA European and World Championships 2010 for Belgian Optimists.

4. Rules :

The International Optispring Regatta will be governed by the rules as defined in the ISAF Racing Rules of Sailing.

5. Protests :

Optimists have to display a red flag to inform about their protests, according to RRS 61.1(a). This changes RRS 61.1.(a)(2).

6. Advertising :

Advertising in accordance to ISAF regulation 20 and **IODA Class Rule 2.8**.

Each boat is required to display on both sides of her hull the stickers of the event-sponsor, if any.

7. Conditions of Entry :

Each boat shall be a full member of her national class association. All boats must have valid measurement certificates.

Belgian boats hand over their **record of equipment used** for this regatta. This record can be downloaded from the website.

8. Pre-registration & Entry Fee :

All entries have to be made by means of this website www.optispring.be.

Entry Fee : **€ 40** if online entry **and** payment before 10-04-2010.

€ 50 after 10-04-2010.

9. Eligibility :

Optimist entries will be limited to 160 boats, pre-registered and payment confirmed.

11. Scoring System :

The Low Point Scoring System (Appendix A of the RRS) will apply. A minimum of three races have to be completed to constitute a series. The total number of races shall not exceed 7 (seven).

12. Prizes :

Prizes will be awarded to :

- The first 15 individual competitors
- The 1st, 2nd and 3rd Benjamin (born in 1999 or later)
- The 1st, 2nd and 3rd Girl
- The **Optispring Challenge Cup** : is the challenge trophy that will be awarded to the team of the country with the best total team score, the 1st Country Team. The total team score is calculated from the cumulated end results of the first three individual sailors from each country.

13. Results :

Results will be available as soon as possible after the event on www.optispring.be .

14. Support Boats :

All support boats have to register at the Race Office and collect a **numbered flag**. They shall fly the designated flag at all times while on the water. A cash **deposit of € 10** will be asked and refunded after return of the flag.

Free use of slipway and free mooring in the Rib Area when registered. See App. B.

The speedlimit on the Grevelingen Lake is 15 km/h.

15. Event Traffic :

Local traffic stream for cars with boats and trailers will be announced on the website.

16. Liability :

Participants compete **entirely at their own risk** and responsibility. The DOCB, R.Y.C.B., the race committee or any person directly or indirectly involved in the organization shall not be liable for personal or material damage or injury, ashore or afloat, which might result from participation or intention to participate in this event. Parents/guardians are responsible for the safety of the sailor. It is the sole responsibility of the parents/guardians of the sailor to decide if the sailor should sail in the weather and sea conditions that might arise during the event. Parents/guardians not personally attending any part of the event must ensure that another adult is authorized and designated to make these decisions for their sailor.

17. Insurance :

All boats must carry a valid third-party liability insurance with a minimum cover of € 500.000,- per event.

18. Social Events :

- Saturday : **Happy Hour** near the restaurant after the races.

20. Midweek Training :

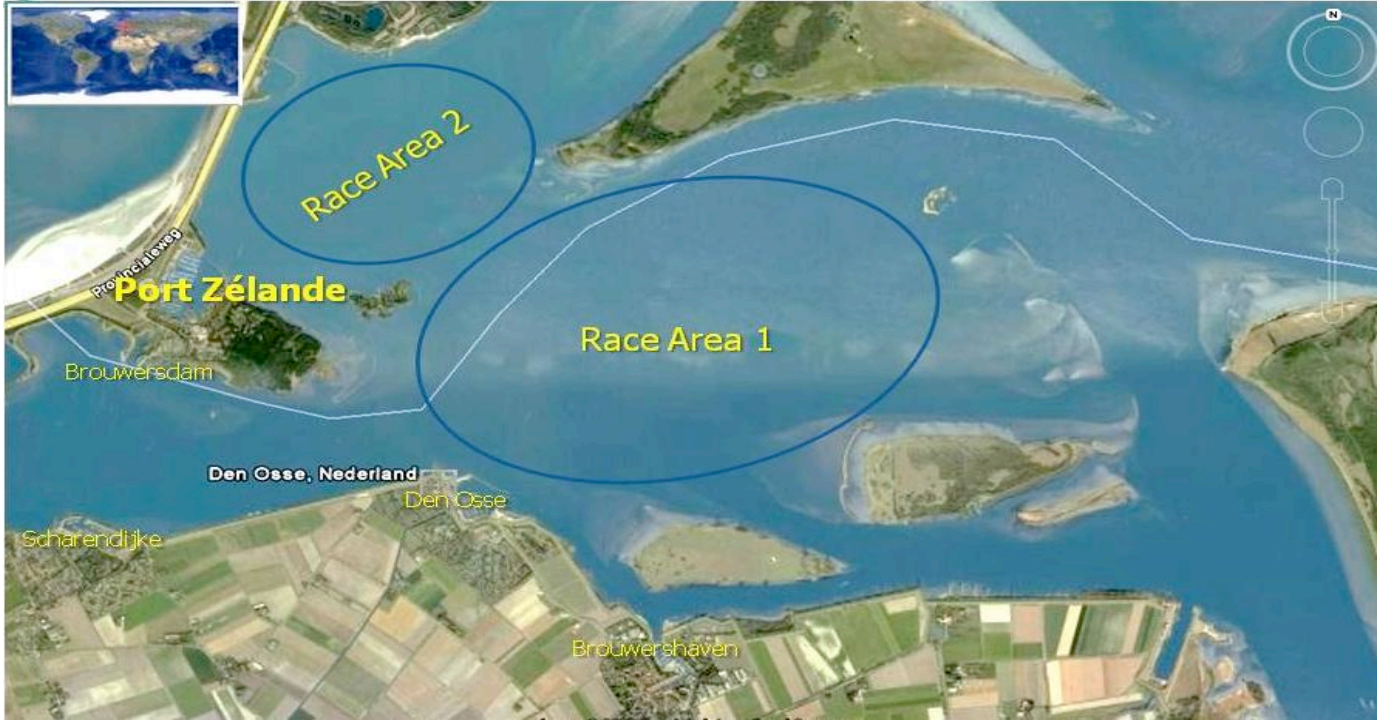

The same rates for the use of the facilities will apply as during the event.
