The intention is to clarify the current practice already in place to ensure the IODA Members that quality racing is upheld for the sailors regardless of the number of entries and to assist the Organisers of the IODA World Championships to manage their financial budget. Proposal: Add Condition 11.5: The number of Jury Officials that shall be appointed to a World Championship is ten 1. persons in total, two of these may be selected by the Organiser. **Current position** None Reason Housekeeping. This proposal intends to clarify the current ongoing practice maintaining 10 Jury officials attending this long and challenging event by ensuring 1. the IODA Members that quality of racing is not sacrificed no matter how many sailors are registered to participate, but at the same time to help Organisers plan their budget.

## Continental Championship

### A Proposal from the Executive Committee

### Purpose or objective:

To provide clarity for the Organising Committee of the European Team Racing Championship to manage efficiently the budgets of the event, and to clarify the existing Condition where no guidance currently exists.

#### Proposal:

Amend and add to Condition 20.2:

1.

The Organising Authority shall provide accommodation, meals, transport to and from the airport to the venue, and local transport for a nominee of the Executive (normally the Vice President of the continent concerned), the IODA Secretaries, and any other IODA committee members, secretaries or the partner of any of the above, in exchange for an adult entry fee. For the European Team Racing Championship, the adult entry fee shall be that of the European Championship of the same year.

#### **Current position**

The Organising Authority shall provide accommodation, meals, transport to and from the airport to the venue, and local transport for a nominee of the Executive (normally the Vice President of the continent concerned), the IODA Secretaries, and any other IODA committee members, secretaries or the partner of any of the above, in exchange for an adult entry fee.
