## **NOTICE OF RACE**

### **Kidibul Cup Cap d'Agde**

### **OPTIMIST**

Cap d'Agde Nautical Center

From Tuesday, October 27, 2020 to Saturday, October 31, 2020

*The notation "[DP]" in the NoR means that the penalty for a breach of that rule may, at the discretion of the jury, be less than disqualification.*

#### **1. RULES :**

---

The regatta will be governed by :

- 1.1 The rules as defined in 2017-2020 Racing Rules of Sailing.
- 1.2 National prescriptions applying to foreign competitors specified in the Appendix "Prescriptions".
- 1.3 Federal regulations.
- 1.4 In case of translation of this notice of race, the French text will take precedence.

#### **2. ADVERTISING [DP] :**

---

Boats shall display advertising chosen and supplied by the Organizing Authority. If this rule is broken, World Sailing advertising Regulation 20.9.2 applies.

#### **3. ELIGIBILITY AND ENTRIES :**

---

- 3.1 The regatta is open to :
  - All boats that comply with the rules of the Optimist class measurement.
  - All proven federal level 3 sailors, born from 2006 to 2011.
  - To sailors of foreign nationality according to the same age criteria.
- 3.2 Eligible boats may enter by completing the online form on the website :

- 3.3 Sailors with a FFVoile Licence must be able to present at the time of registration :
- The membership to Promotion Optimist 2020, which certifies the deposit on the POP site of the following documents :
    - Parental authorization (in annex).
    - Pages 1 and 2 of the IODA booklet corresponding to the boat declared on the event (concordance between sailor and owner of the boat).
  - The 2020 "Competition" type licence.
  - If necessary, the authorization for advertising.
- 3.4 Foreign sailors without a FFVoile licence must present at the time of registration:
- Proof of membership of a National Authority member of World Sailing.
  - Valid proof of insurance in civil liability with a minimum cover of two million Euros
  - A medical certificate of no contraindication to the practice of sailing in competition dating less than a year (written in French or in English).
  - Parental authorization (in annex).
- 3.5 Eligible competitors can register by completing the online form at :

The form will be available from march 1st 2020.

#### **4. CATEGORIES :**

---

- Minims / Cadets: sailors born in 2009, 2008, 2007 and 2006.
- Benjamins: sailors born in 2010 and 2011.

#### **5. FEES :**

---

- 5.1 Required fees are as follows :
- 120 € until september the 6th 2020.
  - From september the 7th 2020, registrations will be increased to € 140.
  - registration will end on october the 11<sup>th</sup> 2020 at midnight.
- 5.2 From the third child of the same family, the registration of the third and subsequent children is reduced by 50% (valid on the rate on the date of registration).
- 5.3 Conditions of repayment :  
In case of withdrawal, the sailors will be reimbursed only in case of force majeure, after decision of the Organizing Authority who may require a medical certificate.

#### **6. QUALIFYING SERIES AND FINAL SERIES :**

---

- 6.1 If there are more than 80 sailors in a category, the regatta may be turned into qualifying and final series.  
The qualifying phase will last at least 2 days, and if at least 4 races have been completed for all groups. The final phase will last at least one day.

- 6.2 The distribution of the first day will be based on the national ranking published 48 hours before the first day of the event.  
Foreign sailors will be randomly distributed.
- 6.3 All Minims groups will run the qualifying series on the same round.
- 6.4 For the final phase, the last Minims group might sail on the round of Benjamins

## **7. SCHEDULE :**

---

Monday, October 26, 2020

From 2.00 pm to 6.00 pm Confirmation of registration

Tuesday, October 27, 2020

from 9.00 am to 6.00 pm Confirmation of registration  
from 2.00 pm to 5.00 pm Various activities offered by the Cap d'Agde Nautical Center.  
at 6.00 pm Opening Ceremony with presentation of the teams of each country.

Wednesday, October 28, 2020

at 10.00 am Coaches Meeting  
at 12.00 am 1<sup>st</sup> warning signal - races to follow.

Thursday October 29, 2020

at 11.00 am 1st warning signal - races to follow.

Friday October 30, 2020

at 11.00 am 1st warning signal - races to follow.

Saturday October 31, 2020

at 10.30 am 1st warning signal - races to follow.

On the last scheduled day of racing, no warning signal will be made after 4.30 pm.

The prize giving ceremony will take place as soon as possible after the races on Saturday 31 October 2020.

A promotional race, open to the only category of Benjamins, can be organized if and only if it does not penalize the smooth running of official races:

- The warning signal of this race will be given following the last race of the day.
- This race will be out of competition, that is to say, subject to a ranking and penalties not counting for the event.
- This race will be subject to specific information.

## **8. MEASUREMENT :**

---

8.1 At the confirmation of registration, each sailor shall produce :

- The paper version, completed, of its declaration of measurement (models available on the site of the POP, <http://promotion-optimist.fr/fr/pages/Gauge/>).
- His life jacket and whistle, in accordance with ISO 12402-5 (level 50) or its equivalent indicating the serial number and the date of manufacture.

8.2 Measurement checks may be organized throughout the event.

## **9. SAILING INSTRUCTIONS :**

---

The sailing instructions and any appendix will be:

- Displayed on the official board according to the federal prescription.
- Available in electronic version, at the latest on the first day of the event, at the following address :

## **10. RACING AREAS :**

---

The race area is located on the Richelieu beach side and on the east side of the harbor dike (see marine map in appendix).

## **11. THE COURSES :**

---

The courses to be sailed are IODA trapeze type with a gate.

## **12. PENALTY SYSTEM :**

---

In the case of umpired races, RRS 44.1 is changed so that the two-turns penalty is changed to a one-turn penalty.

## **13. SCORING :**

---

- 13.1 Two races are required to be completed to constitute a series.
- 13.2 When fewer than 4 races have been completed, a boat's series score will be the total of her race scores.  
When 4 or more races have been completed, a boat's series score will be the total of her race scores excluding her worst score.
- 13.3 In the event of a tie, the World Sailing Annex A8 system will apply.

## **14. SUPPORT PERSONS : [DP]**

---

- 14.1 Coaches and support persons must pre-register at the following URL :  
<http://centrenautique-capdagde.com/kidibul-cup-capdagde2020/>.
- 14.2 Coaches shall provide, at the latest at the confirmation of registration, the list of sailors under their responsibility during the event.
- 14.3 Coaches and support boats will be moored to the pontoon reserved by the Organizing Authority in the harbor.
- 14.4 Some coaches and support boats may be included in the safety system at the discretion of the organizer.

## **15. RIGHT TO IMAGE :**

---

By participating in this event, each sailor or his legal representative, tacitly authorizes the organizing authority, the OPTIMIST Promotion, the sponsors of the event and the photographers or cameramen to use and broadcast, without limitation, moving photos or static, racing or ashore, films or television recordings and other reproductions of himself during and after the period of the competition entitled «KIDIBUL CUP CAP D'AGDE» to which the rider participates in his full agreement. It allows a free exploitation of the said images without any compensation for its right to the image.

## **16. RADIO COMMUNICATION : [DP]**

---

Except in case of emergency, a boat that is racing shall neither make radio transmission nor receive radio communication that is not available to all boats. This restriction also applies to mobile phones.

## **17. PRIZES**

---

Prizes will be distributed as follows :

- To the first 3 of the scratch ranking and the first 3 girls, in Minims and in Benjamins (if they are not already rewarded),
- To the first boy and the first girl 1<sup>st</sup> year (born in 2008) in Minims if they are not already rewarded.
- To the first boy and the first girl 1<sup>st</sup> year (born in 2010) in Benjamins if they are not already rewarded.

## **18. DISCLAIMER OF LIABILITY :**

---

Competitors participate in the regatta entirely at their own risk. The decision to race or stay in the race is their sole responsibility.

The organizing authority will not accept any liability for material damage, personal injury or death sustained in conjunction with or prior to, during or after the regatta.

**ANNEXE PRESCRIPTIONS FEDERALES**  
**FFVoile Prescriptions to RRS 2017-2020 (translated for foreign competitors)**

FFVoile Prescription to **RRS 25** (Notice of race, sailing instructions and signals) :

For events graded 4 and 5, standard notices of race and sailing instructions including the specificities of the event shall be used. Events graded 4 may have dispensation for such requirement, after receipt of FFVoile approval, received before the notice of race has been published.

For events graded 5, posting of sailing instructions will be considered as meeting the requirements of RRS 25.1 application.

(\*) FFVoile Prescription to **RRS 64.3** (Decisions on protests concerning class rules) :

The jury may ask the parties to the protest, prior to checking procedures, a deposit covering the cost of checking arising from a protest concerning class rules.

(\*) FFVoile Prescription to **RRS 67** (Damages) :

Any question about or request of damages arising from an incident involving a boat bound by the Racing Rules of Sailing or International Regulation to Prevent Collision at Sea depends on the appropriate courts and cannot be dealt by the jury.

(\*) FFVoile Prescription to **RRS 70. 5** (Appeals and requests to a national authority) :

The denial of the right of appeal is subject to the written authorization of the Fédération Française de Voile, received before publishing the notice of race. This authorization shall be posted on the official notice board during the event.

(\*) FFVoile Prescription to **RRS 78.1** (Compliance with class rules; certificates) :

The boat's owner or other person in charge shall, under his sole responsibility, make sure moreover that his boat complies with the equipment and security rules required by the laws, by-laws and regulations of the Administration.

(\*) FFVoile Prescription to **RRS 86.3** (Changes to the racing rules) :

An organizing authority wishing to change a rule listed in RRS 86.1(a) in order to develop or test new rules shall first submit the changes to the FFVoile, in order to obtain its written approval and shall report the results to FFVoile after the event. Such authorization shall be mentioned in the notice of race and in the sailing instructions and shall be posted on the official notice board during the event.

(\*) FFVoile Prescription to **RRS 88** (National prescriptions) :

Prescriptions of the FFVoile shall neither be changed nor deleted in the notice of race and sailing instructions, except for events for which an international jury has been appointed.

In such case, the prescriptions marked with an asterisk (\*) shall neither be changed nor deleted in the notice of race and sailing instructions. (The official translation of the prescriptions, downloadable on the FFVoile website [www.ffvoile.fr](http://www.ffvoile.fr), shall be the only translation used to comply with RRS 90.2(b)).

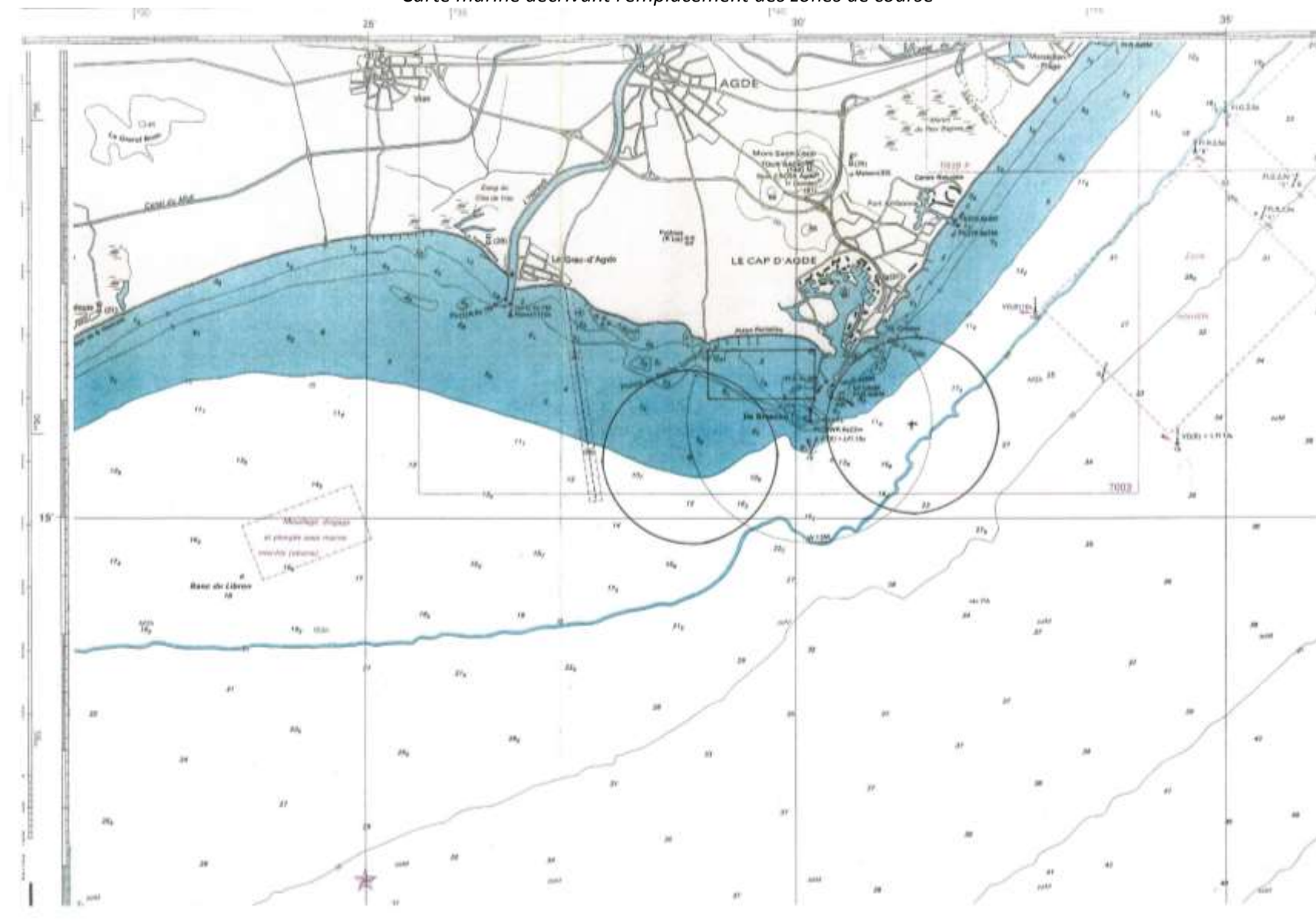
(\*) FFVoile Prescription to **RRS 91(b)** (Protest committee) :

The appointment of an international jury meeting the requirements of Appendix N is subject to prior written approval of the Fédération Française de Voile. Such authorization shall be posted on the official notice board during the event.
