## **1. RULES :**

---

The regatta will be governed by :

- 1.1 The rules as defined in Racing Rules of Sailing.
- 1.2 National prescriptions translated in english applying to foreign competitors specified in the Appendix "Prescriptions".
- 1.3 Federal regulations.
- 1.4 The rules relating to the health crisis specified in the appendix.
- 1.5 In case of translation of this notice of race, the French text will take precedence.

## **2. SAILING INSTRUCTIONS (SI)**

---

The sailing instructions and any appendices will be:

- Published according to federal prescription.

3.2 [DP] From the first warning signal until the end of the last race of the day, except in an emergency, a boat shall neither send nor receive voice data or data which is not available. for all boats.

### 4. ELIGIBILITY AND ENTRIES

---

Depending on the evolution of the health crisis, the Organizing Authority may modify the conditions for registration and / or eligibility.

In the unprecedented "COVID" context, the Organizing Committee may cancel the event.

Taking into account the COVID risk:

By registering for the "Optimist Kidibul Cup", all competitors certify that they are aware of the Covid-19 risk, as well as those accompanying them, and have taken it into account.

Each competitor and guide is therefore perfectly aware:

- o Hygiene and physical distancing measures, known as "barrier gestures" to be observed anywhere and at any time, as well as additional provisions published by the Ministry of Sports, and undertakes to comply with them,
- o The risk of contamination accentuated by the proximity of another person, in particular when sailing on a crew or double-handed sailboat, or any other situation of proximity of less than one meter, without adequate reinforced protections,
- o That despite the implementation of reinforced means of protection, the practice may expose to a health risk, in particular contamination by COVID,
- o That despite the arrangements made and the resources involved, the host establishment, the structure / the club, cannot guarantee total protection against exposure to and contamination from COVID. It releases the Organizing Authority from any liability in the event of contamination,
- o That all these measures aim to preserve the health and physical capacities of the competitors, guides and members of the Organizing Authority participating in the regatta.

4.1 The regatta is open to:

- All boats conforming to the Optimist class measurement rules.
- All proven federal level 3 runners born from 2007 to 2012.
- To runners of foreign nationality according to the same age criteria.

4.2 Categories:

- Minimes / Cadets: runners born in 2010, 2009, 2008 and 2007.
- Benjamins: runners born in 2011 and 2012.

4.3 Documents required for registration:

4.3.1 Competitors must provide, at the time of registration:

- The 2021 "Competition" licence.
- The 2021 certificate of membership in the Optimist class, presenting the sail number identical to that declared on the event, which certifies the deposit and control, on the class site.

4.3.2 Foreign competitors who do not have an FFVoile licence must present at the time of registration:

- Proof of their membership of a National Authority member of World Sailing.
- A valid proof of liability insurance with a minimum coverage of two million euros.
- A medical certificate of no contraindication to the practice of competitive sailing dating back less than one year (written in French or in English).
- Parental authorization.

The form will be available from June 30, 2021.

Registrations will close on Monday, October 11, 2021 at midnight.

4.5 To be considered entered for the event, a boat must meet all entry requirements and pay all fees.

## 5. FEES :

---

5.1 Required fees are as follows :

- 120 € until september the 13th 2021.
- From september the 14th 2021, registrations will be increased to € 150.
- registration will end on october the 11<sup>th</sup> 2021 at midnight.

5.2 From the third child of the same family, the registration of the third and subsequent children is reduced by 50% (valid on the base rate of 120 €).

5.3 Conditions of repayment :

In case of withdrawal, the sailors will be reimbursed only in case of force majeure, after decision of the Organizing Authority who may require a medical certificate.

## 6. ADVERTISING [DP] :

---

Boats shall display advertising chosen and supplied by the Organizing Authority. If this rule is broken, World Sailing advertising Regulation 20.9.2 applies.

## 7. QUALIFYING SERIES AND FINAL SERIES :

---

7.1 If there are more than 80 sailors in a category, the regatta may be turned into qualifying and final series.

The qualifying phase will last at least 2 days, and if at least 4 races have been completed for all groups. The final phase will last at least one day.

- 7.2 The distribution of the first day will be based on the national ranking published 48 hours before the first day of the event.  
Foreign sailors will be randomly distributed.
- 7.3 All Minims groups will run the qualifying series on the same round.
- 7.4 For the final phase, the last Minims group might sail on the round of Benjamins

On the last scheduled day of racing, no warning signal will be made after 4.30 pm.

The prize giving ceremony will take place as soon as possible after the races on Saturday 30 October 2021.

A promotional race, open to the only category of Benjamins, can be organized if and only if it does not penalize the smooth running of official races:

- The warning signal of this race will be given following the last race of the day.
- This race will be out of competition, that is to say, subject to a ranking and penalties not counting for the event.
- This race will be subject to specific information.

9.2 Gauges checks may be organized throughout the duration of the competition.

## **11. RACING AREAS :**

---

The race area is located on the Richelieu beach side and on the east side of the harbor dike (see marine map in appendix).

## **12. THE COURSES :**

---

The courses to be sailed are IODA trapeze type with a gate.

## **13. PENALTY SYSTEM :**

---

In the case of umpired races, RRS 44.1 is changed so that the two-turns penalty is changed to a one-turn penalty.

## **14. SCORING :**

---

14.1 Two races are required to be completed to constitute a series.

## 14.2

- a) When fewer than 4 races have been completed, a boat's series score will be the total of her race scores.
- b) When 4 or more races have been completed, a boat's series score will be the total of her race scores excluding her worst score.

14.3 In the event of a tie, the World Sailing Annex A8 system will apply.

## 15. SUPPORT PERSONS : [DP]

---

15.1 Coaches and support persons must pre-register at the following URL :

15.2 The coaches will complete, no later than the registration confirmation, the form presenting the list of runners they are supervising on the water during the event.

15.3 Coaches and support boats will be moored to the pontoon reserved by the Organizing Authority in the harbor.

15.4 Some coaches and support boats may be included in the safety system at the discretion of the organizer.

## 16. BOATS RENTED OR LOANED

---

A rented or loaned boat may carry nationality letters or a sail number not in accordance with its class rules, provided that the race committee has approved its sail identification before the first race.

## 17. PLACE IN THE PORT

---

[DP] Boats must remain in their assigned seats while in the boat park.

## 18. DATA PROTECTION

---

### 18.1 Right to image and appearance:

By participating in this competition, the competitor and his legal representatives authorize the organizing authority, the OPTIMIST class, the FFVoile and their sponsors to use their image and name free of charge, to show photos at any time (during and after the competition). moving or static, films or television recordings, and other reproductions of himself taken during the competition, and this on any medium and for any use related to the promotion of their activities.

### 18.2 Use of participants' personal data

By participating in this competition, the competitor and his legal representatives consent and authorize the FFVoile and its sponsors as well as the organizing authority and the OPTIMIST class to use and store their personal data free of charge. These data may be published by the FFVoile and its sponsors. The FFVoile in particular, but also its sponsors may use this data for software development or for marketing purposes. In accordance with the General Data Protection Regulations (RGPD), any competitor who has communicated personal data to the FFVoile can exercise his right of access to data concerning him, have them rectified and, depending on the situation, delete or limit them, and oppose it, by contacting [dpo@ffvoile.fr](mailto:dpo@ffvoile.fr) or by mail to the head office of the French Sailing Federation, specifying that the request relates to personal data.

## **19. RISK ESTABLISHMENT**

---

RRS 3 states: "The decision of a boat to participate in a race or to remain in the race is her sole responsibility. By participating in this event, each competitor accepts and recognizes that sailing is a potentially dangerous activity with inherent risks. These risks include strong winds and rough seas, sudden changes in weather conditions, equipment failure, errors in maneuvering the boat, improper navigation of other boats, loss of balance on an unstable surface. and fatigue, leading to an increased risk of injury. The risk of material and / or bodily damage is therefore inherent in the sport of sailing.

## **20. PRIZES**

---

The prizes will be distributed as follows:

- To the first 3 of the scratch classification and to the first 3 girls, in minimes and benjamins (if they have not already been rewarded).
- To the first boy and to the first girl minimes 1st year (born in 2010) if they are not already rewarded.
- To the first boy and the first girl benjamins 1st year (born in 2012) if they have not already been rewarded.
- To the first minime team, by nation, taking into account the four best results, and including at least one girl.

**ANNEXE PRESCRIPTIONS FEDERALES**  
**FFVoile Prescriptions to RRS 2017-2020 (translated for foreign competitors)**

FFVoile Prescription to **RRS 25** (Notice of race, sailing instructions and signals) :

For events graded 4 and 5, standard notices of race and sailing instructions including the specificities of the event shall be used. Events graded 4 may have dispensation for such requirement, after receipt of FFVoile approval, received before the notice of race has been published.

For events graded 5, posting of sailing instructions will be considered as meeting the requirements of RRS 25.1 application.

(\*) FFVoile Prescription to **RRS 64.3** (Decisions on protests concerning class rules) :

The jury may ask the parties to the protest, prior to checking procedures, a deposit covering the cost of checking arising from a protest concerning class rules.

(\*) FFVoile Prescription to **RRS 67** (Damages) :

Any question about or request of damages arising from an incident involving a boat bound by the Racing Rules of Sailing or International Regulation to Prevent Collision at Sea depends on the appropriate courts and cannot be dealt by the jury.

(\*) FFVoile Prescription to **RRS 70. 5** (Appeals and requests to a national authority) :

The denial of the right of appeal is subject to the written authorization of the Fédération Française de Voile, received before publishing the notice of race. This authorization shall be posted on the official notice board during the event.

(\*) FFVoile Prescription to **RRS 78.1** (Compliance with class rules; certificates) :

The boat's owner or other person in charge shall, under his sole responsibility, make sure moreover that his boat complies with the equipment and security rules required by the laws, by-laws and regulations of the Administration.

(\*) FFVoile Prescription to **RRS 86.3** (Changes to the racing rules) :

An organizing authority wishing to change a rule listed in RRS 86.1(a) in order to develop or test new rules shall first submit the changes to the FFVoile, in order to obtain its written approval and shall report the results to FFVoile after the event. Such authorization shall be mentioned in the notice of race and in the sailing instructions and shall be posted on the official notice board during the event.

(\*) FFVoile Prescription to **RRS 88** (National prescriptions) :

Prescriptions of the FFVoile shall neither be changed nor deleted in the notice of race and sailing instructions, except for events for which an international jury has been appointed.

In such case, the prescriptions marked with an asterisk (\*) shall neither be changed nor deleted in the notice of race and sailing instructions. (The official translation of the prescriptions, downloadable on the FFVoile website [www.ffvoile.fr](http://www.ffvoile.fr), shall be the only translation used to comply with RRS 90.2(b)).

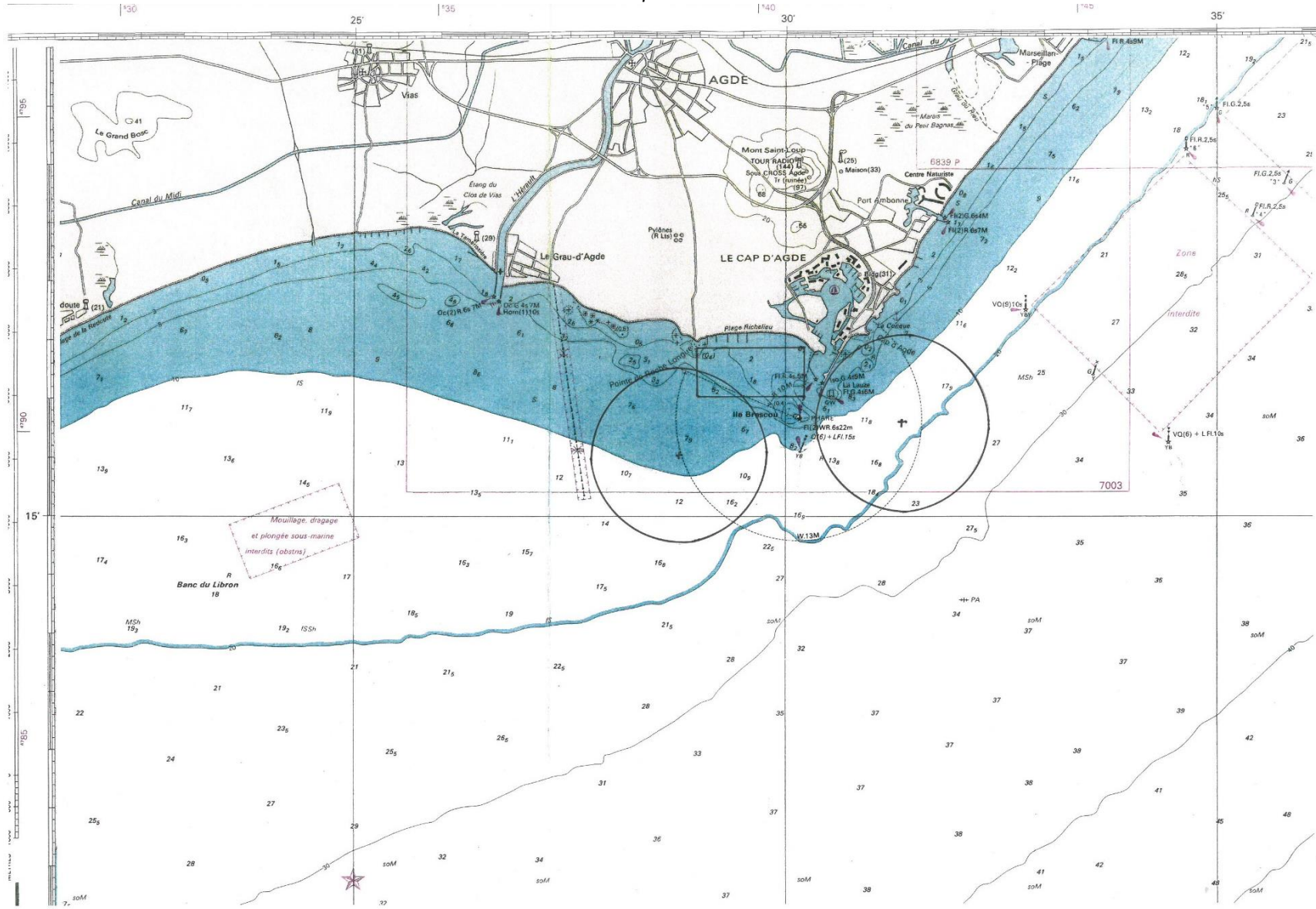
(\*) FFVoile Prescription to **RRS 91(b)** (Protest committee) :

The appointment of an international jury meeting the requirements of Appendix N is subject to prior written approval of the Fédération Française de Voile. Such authorization shall be posted on the official notice board during the event.
