The Organising Authority shall provide return flights in accordance with the IODA Travel Policy, accommodation, meals, transport to and from the airport to the venue, and local transport for the PRO and the Chief Measurers/Deputy Measurer(s).

Current position

The Executive Committee shall appoint for each championship an IODA Principal Race Officer (see 11.4), a chief measurer and deputy measurer(s) (see 13.2) and nominee of the Executive (normally the Vice President for the continent concerned). The Organising Authority shall provide accommodation, meals, transport to and from the airport to the venue, and local transport, in exchange for an adult entry fee.
